

NABET-CWA ELECTION NOTICE REGION 1 VICE PRESIDENT (RVP-1)

Members wishing to run for election as Region One Vice President may obtain nominating petitions from their Local beginning January 4, 2021. Nominating petitions must be filed by April 15, 2021 with the Sector Office, in Washington, DC.

Candidates must be active NABET-CWA members in good standing in Region 1 for at least three (3) years immediately preceding nomination. Election procedures are specified in Article VII of the NABET-CWA Sector By-Laws.

Ballots will be mailed to all active Region 1 members in good standing to the address on file with the Sector Office no later than April 30, 2021. If you do not receive a ballot within a reasonable time after May 10, 2021, and believe you are eligible to vote, notify your Local so that an inquiry may be made to the Washington office, or call the office directly (202-434-1254) to request a duplicate ballot.

Ballots must reach the Sector Office by 10:00am EDT, on May 27, 2021, and will be counted on that day. The candidate who is elected will begin a three-year term on the Sector Executive Council on July 1, 2021.



NABET-CWA Election Notice Regions 1, 3, and 5

NABET-CWA members wishing to run for election as Regional Vice President in NABET-CWA Regions 1, 3 and 5 may obtain nominating petitions from their Local beginning January 4, 2021. Petitions must be filed by April 15, 2021 in the Sector Office, in Washington, D.C.

Candidates must be active NABET-CWA members in good standing in their Region for at least three (3) years immediately preceding their nomination. Election procedures are specified in Article VII of the NABET-CWA Sector By-Laws.

The written and signed signature requirements for the nominating petitions are satisfied by a true and correct copy of a nominating petition page with an original signature (and printed name) forwarded by the signatory by fax, text, email, or other electronic means of transmission (for example, a nominating petition page which is signed, scanned, and returned to the candidate via PDF attachment). Candidates should retain copies of the transmitting communications to establish compliance with this requirement in the event of a challenge to a signature.

Voting for these offices will be conducted by secret mail ballot. Ballots will be mailed no later than April 30, 2021, to all active members in good standing, in each of the three Regions, to the address on file with the Sector Office. If you have moved, please be sure your address is current with your Local and with the Sector Office.

If you do not receive a ballot within a reasonable time after May 10, 2021, and believe you are eligible to vote, notify your Local so that an inquiry may be made to the Sector, or call the Local office directly to request a duplicate ballot.

Ballots must reach the Sector Office by 10:00 a.m. Eastern Daylight Time, on May 27, 2021 and will be counted that day. Candidates who are elected will begin a three-year term on the Sector Executive Council on July 1, 2021.
