To be eligible to run for the above, you must be and have been an active member in good standing in the Local continuously for not less than three (3) years prior to the due date of such election.

Nominating petitions will be available as of Friday, February 17, 2023. They are available via mail, email, fax or in person.

Candidates must be regularly employed in the functional group they desire to represent. They must be and have been members in good standing in NABET-CWA continuously for the three years immediately prior to the date of nominations. In the case of Daily Hire members, “regularly assigned” to the Local Executive Board Unit shall mean that they have worked in the Local Executive Board Unit for which they are a candidate for at least 130 working days within the last 365 days on the final day of submission of petitions for the office.

Petitions must contain signatures (and printed names) of not less than twenty (20) active members in good standing in the Local as of the date petitions are due.

These petitions, which must have not less than twenty (20) names and signatures of members in good standing in the Local along with an optional brief biography [Section 7.3(C) of the Local By-Laws], must be filed in the Union Office by 5:00 PM, Friday, March 31, 2023.

Requirements for valid Petitions and signatures can be found in Article 7.7 of the Local By-Laws and on the Nominating Petition.

**ALL PETITIONS MUST BE RETURNED BY MAIL OR IN PERSON BY THE DESIGNATED TIME TO THE NABET-CWA LOCAL 11 OFFICES LOCATED AT 49 WEST 37<sup>TH</sup> STREET, 16<sup>TH</sup> FLOOR, NYC 10018.**

The election will be by secret ballot, conducted by the Election Committee at the NABET-CWA Local 11 offices.

The due date of the elections is Thursday, April 27, 2023. The terms of office will run until April 2025.
