TO: All NABET-CWA Local 11 Active Members and Retirees

Please be advised that the applications for the Local 11 Scholarship Awards (\$500.00 per year) are now available at the Union office, 49 West 37th Street, 16th Floor. They are available via email and on the Local 11 website at www.nabetlocal11.org or by calling the Local 11 office at 212-757-3065.

The following are the eligibility requirements for the Local 11 Scholarship Award:

- 1) The Award is open to any retiree or active member of Local 11 in good standing. The member or retiree may apply for himself or sponsor a member of his immediate family, (wife, husband, son or daughter).
- 2) The applicant must presently be a fully matriculated graduate (6 or more credits) or undergraduate student (12 or more credits) at any accredited college, institute, university or any other facility of higher learning.
- 3) This Local 11 Award shall be granted only once to any applicant, but no other Award would be a cause of ineligibility.

REQUIREMENTS

- 1) Applicants must submit proof of present attendance at the school of higher education, i.e., copy of Fall 2025 or Spring 2026 Bursar's or Registrar's receipt or class schedule listing 12 credits or more (undergraduate) or 6 credits or more (graduate).
- 2) Applicants must sign the disclaimer attached to the application.
- 3) To qualify, all forms must be filled out completely.

TERMS

- 1) The Award is good for a maximum of 4 years within a 5-year continuous period and may be used in combination (if needed) of undergraduate and graduate work if the applicant has less than 4 years of undergraduate work remaining and is accepted for graduate study.

METHOD OF SELECTION

- 1) The winner or winners shall be drawn by lot.
- 2) Applications must be received at the Local 11 office no later than 5:00 PM, Friday, February 27, 2026.
